



Application for Reassessment or Cancellation of a Lodgment

Failed Instruments

Section 236 of the *Duties Act 2001*

Statutory declaration

Using this statement

This statement should be used to either:

- Apply for a refund if you have paid duty on an instrument which subsequently failed in its intended operation and has become useless. An application for a refund must be made:
 - a) within three years after the initial assessment; or
 - b) twelve months after the instrument has failed, whichever is the later.
- Apply to cancel a lodgement where an assessment has not yet been made for an instrument, but the instrument has failed in its intended operation and has become useless since the time of lodgement.

About statutory declarations

A statutory declaration is a written statement declared to be true in the presence of an authorised witness.

The following people are authorised to witness your signature on a statutory declaration:

- Registered health practitioner (such as a doctor, pharmacist, nurse);
- Legal practitioner;
- Bank officer, credit union officer, or finance company officer with five or more years of continuous service;
- Judge or magistrate of a court;
- Teacher employed full-time at a school or tertiary education institution;
- Veterinary surgeon;
- Commissioner for Affidavits and Declarations;
- Police officer; and
- Justice of the Peace.

If it has not already been submitted, please include the stamped original instrument.

Who should complete this statement?

This statement should be completed by the person who has paid duty, or the person liable to pay the duty, on an instrument that subsequently failed in its intended operation.
