

Application to waive payroll tax - Taxpayers in the Hospitality, Tourism, and Seafood industries

About the waiver and this form

Use this form to apply for a waiver of payroll tax for wages paid or payable to eligible employees in the 2019-20 financial year where you reasonably believe you will meet the eligibility criteria below.

Eligibility criteria

Tasmanian employers must meet the following eligibility criteria in the 2019-20 financial year to qualify for the waiver of payroll tax for wages paid or payable to eligible employees in that year. Eligible employees are only those employees who solely or predominantly work in one or more of the relevant industries:

- You must employ at least one employee (eligible employee) who solely or predominantly works in one or more of the hospitality, tourism or seafood industries (relevant industry); **and**
- One of the following must apply:
 1. you are not grouped and only pay wages in Tasmania; **or**
 2. you are not grouped and the Tasmanian portion of your wages will be 50 per cent or more of your total Australian Wages; **or**
 3. you are grouped and the Tasmanian portion of the Australian Group Wages will be 50 per cent or more of the group's Australian Group Wages.

You will need the following details to complete the form:

- your account number; and
- an estimate of the required components of your wages for the 2019-20 financial year.
