Who should use this form?

- a) Employers registered for payroll tax in Tasmania who anticipate recruiting additional employees between 30 June 2014 and 30 June 2015, and who maintain that employment to at least 30 June 2016;
- b) Payroll tax registrants who are **members of a group** may submit either:
 - one form for the entire group; or
 - a separate form for each member of the group.

Where a new payroll tax registrant becomes a member of a group after 30 June 2014, a separate form should be submitted for that member of the group as an individual claimant for the rebate.

Current payroll tax taxpayers must forward their Registration Form to the State Revenue Office no later than 21 July 2015.

After 21 July 2015, **new payroll tax registrants** must forward their Registration Form to the State Revenue Office no later than 21 days after being registered for payroll tax.
