- A company that has not owned land in Tasmania in the past three financial years, but is now purchasing land in the State.

- Before completing your statement of company details, it is recommended that you read the [Guideline Grouping of Related Companies – Land Tax](#).
- With limited exceptions, the grouping provisions also apply to land held in trust by related companies, regardless of the identity of the beneficiaries of those trusts.
- Land held in trust by related companies is separately aggregated and assessed from non-trust land.
- This statement must be signed by a director, secretary or authorised representative of the company.
