About the rebate and this form

Use this form to register to claim the payroll tax rebate for eligible Apprentices, Trainees and Youth Employees. Once your registration has been received, an electronic claim form (in Excel) will be provided. You are required to:

- lodge your claims using that approved form (as issued by the Commissioner of State Revenue);
- include any additional information requested by the Commissioner; and
- make your claim within the nine-month period immediately after the end of the relevant financial year.

Eligibility criteria

Please read the [Payroll Tax Rebate \(Apprentices, Trainees and Youth Employees\) Guideline](#) for details about the eligibility criteria before making a claim for an employee.

Information needed to complete this form

You will need the following details to complete the form:

- your payroll tax account number;
- bank account details; and
- listings of employees from your payroll tax system as at eligibility dates.
